Meeting Minutes February 22, 2023

CALL TO ORDER

Chairman Miner called the monthly meeting to order on Wednesday, February 22, 2023, at 6:45 p.m.

APPROVAL OF MINUTES

Motion made by Vice Chairman Upton to approve the minutes from the 2023 Reorganization and regular January meeting. Second by Supervisor Hann. All in favor, motion carried.

GRANT REIMBURSEMENT

District Attorney Richard Bower presented Connellsville Township with a check for \$2,000.00 out of his personal account for the Township's Code Enforcement program. The money for the code enforcement program was originally to come out of seized monies from the DA Office, this was not possible, and DA Bower was kind enough to donate the money to the Township personally.

PUBLIC PARTICIPATION -

*Jamie Hough – 1206 Springfield Pike sewage issue. They were assured all units were tied into sewage, 1206 is not. Concerned with what is going on now and what will be done? Will it be re-tested, how is she to know if it is safe. Wants to know for sure it is taken care of. When the next dye test is done Jamie would like to be present to be assured it has been done.

*Mr. Fosbrink – Asked the Township to sponsor a roadway clean-up on Narrows Rd, (Jon Gilpin explained their may be a program through the Recycling Center and we can talk to Sheila Shea and see if there are programs to help with this), Mr. Fosbrink wants clarification of the burning ordinance to know if you need a permit to have a camp fire, (ordinance was explained by Jon Gilpin), Mr. Fosbrink asked about compost pick up and picking up tree branches. Asked if composting is allowed on the property. (Composting is allowed on property, and the Township will pick up tree branches, not entire trees.) Asked if Township has garbage and junk car ordinance. (Code Enforcement Officer Chad Savage will look into the properties in question). The property below him has a lot of

garbage accumulated, Porterfield garage is falling down. Wants to know if landlords need to register by March 15th. Asked if Landlord registration is to be made public. (Chairman Miner will ask our Solicitor about this.)

*Mr. Calisti – complimented the Township on the new website, asked if new info will be added. Asked how to know what is going on by looking at the agenda to the meeting, wants to see more info to know if he wants to come to the meeting. Solicitor Melinda Dellarose explained that the agenda is not to go into detail, just outline what will be discussed.

- * Report for the month was read by Jon Gilpin and is on file in the office. Along with the regular monthly report it was brought to his attention that a tree was leaning across Church St in the Hillcrest Mobile Home Park and in danger of falling and hitting the mobile home across the street. It was determined the tree was on private property, off the right of way. Public Works spoke with Phillip McNair, owner of the property, and informed him of the situation. Mr. McNair agreed to take care of it and remove the tree. As of today, the tree has been removed.
- * Public Works, along with Kerry Bell from Widmer Engineering, investigated an issue of standing water collecting on Shultz Ave, at the intersection with Crawford Avenue, by Dr. Ellis' office. There is an unknown type of gravel pit on the bend of Shultz Ave before the Geibel baseball field. There are no stormwater draining systems in the area. Kerry Bell's recommendations are to dig to determine what the unknown gravel pit is and add more stone in the area to make a French drain for the water to seep into and repave that section of Shultz Ave., leaving a small dip between Dr. Ellis' parking lot to let the stormwater naturally flow into the stone pit.
