Chairman Miner -

*Chairman Miner stated that the Township has been awarded a dirt and gravel road grant for Casparis. We are waiting for the contract.

*Dye test results for Striner-Lewis property have been completed and the results were clean. A letter will be sent to notify them.

UNFINISHED BUSINESS -

Motion by Chairman Miner to accept a one-year extension of the garbage contract with Noble Environmental, with a rate of 20.00/month beginning in January 2024. Noble will also be permitted to suspend garbage and recycling pick-up for any resident who neglects to submit payment, and the bill is forty-five (45) days past due. A letter will be sent to the account holder notifying them of the delinquency and potential suspension of their account. The account holder will have ten (10) days to pay in full or make a down payment on a three (3) month payment plan. The Township will be notified of all account suspensions. This also applies to any delinquent accounts prior to January of 2024. After being notified of an account suspension the Township can fine anyone who does not have garbage and recycling pick-up; Ordinance 2019-3. Second by Supervisor Hann. All in favor, motion carried.

*The Minimum Municipal Obligations (MMO's) for the pension plans have been received. The total combined MMO is \$26,934; Estimated state aid is \$15,500.00.

*Ballot received for PSATS Unemployment Compensation Group Trust 2023 Ballot for Election of Trustees, needs filled out and signed.

*Motion by Chairman Miner to reimburse Jim Stephens (Tax Collector), \$1.00 per bill for the cost of mailing out approximately 210 bills for per capita tax. These were sent to

people who were not listed in the per capita book and needed to be added. Second by Supervisor Hann. All in favor, motion carried.

*Motion by Chairman Miner to set Trick or Treat in the Township for Sunday, October 29, 2023, from 6:00 to 8:00 p.m. Second by Supervisor Hann. All in favor, motion carried.

*Motion by Chairman Miner to set the road opening fee for Colombia Gas' Williams Ave, Royal Heights area project, as \$300.00 per Road Opening. All in favor, motion carried.
