CALL TO ORDER

Chairman Miner called the monthly meeting to order on Wednesday, February 28, 2024, at 6:00 p.m.

APPROVAL OF MINUTES

Motion made by Supervisor Hann to accept the regular meeting minutes and reorganization meeting minutes from January 2nd, 2024. Second by Vice Chairman Upton. All in favor, motion carried.

PUBLIC PARTICIPATION -

SECRETARY'S REPORT (Darla Hann reported)

- -5 burn permits were issued in January.
- -Forms completed to date are: 2024 Tax Info, 2024 Survey of Financial Condition, Elected & Appointed Officials Form, MS-965 to PennDOT and AG 385 Form (pension). The Annual Recycling Report will be submitted as soon as I receive tonnages for DG.
- -Had set up a Cost-of-Living increase for Roger Adams, after he passed, I contacted Feaster, Duda Actuarial and PNC to stop payment from his pension.
- -Notice received from the Solicitor that liens were filed on 2 properties for property maintenance done by the Township.
- -The old salt shed was purchased and removed.

- -5.66 tons of recyclables were collected in the bin from the County that is located here.

- It was decided to table a decision on updating the cameras and security system.
- -We received a copy of an ordinance from the County concerning parcel improvements; it states that a copy of all permits issued by the Township or third party for the Township is to be submitted by the first day of the month for the previous month. It was decided that Darla would submit these.
- -I have included a Statement of Financial Interest in everyone's packet. This needs to be returned to the office by May 1, 2024.
- Discussion of the terms of the Board for the BTCTJSA was tabled until next month.
- -Discussion concerning the Experience Works Program. It was decided to move forward with this, asking for two (2) workers. Darla and Todd will contact the Vo-tech to see if anyone in their program is interested.
