- I. Call to Order- Chairman Miner called the monthly meeting to order on Thursday, June 13, 2019 at 7:04 p.m.

- **XI. Unfinished Business –** Chairman Miner said that we sold a Toro Mower and Trailer in exchange for purchasing a Brush Hog.
- XII. **New Business** – Motion to begin the interview process to hire a casual, part time public works employee made by Supervisor Carson. Second by Vice Chairman Hann. All in favor. Motion carried. Motion by Chairman Miner to approve a wage increase from \$7.25 to \$8.00 for the summer casual, part-time help. Second by Vice Chairman Hann. All in favor. Motion carried. Motion by Supervisor Carson to have a bin brought in for shredding through Westmoreland Blind Association. Second by Vice Chairman Hann. Motion by Supervisor Carson to close the Health and Benefits and Payroll accounts and open a money market for the Liquid Fuels, Equipment Fund, General Fund, and Capital Expenditures accounts. Second by Vice Chairman Hann. All in favor. Motion carried. Chairman Miner stated that we are purchasing a CAT Front End Loader from Cleveland Brothers and will be putting \$26,000 down on the purchase from the Liquid Fuels account. The purchase price of the CAT Loader is \$75,215.00 and the Township plans to borrow the difference from FNB for 5 years at 3.6% interest. Our Co-Stars account number for this purchase is 3021. Motion by Supervisor Carson to purchase the CAT Front End Loader. Second by Vice Chairman Hann. All in favor. Motion carried. Chairman Miner discussed with the group that we are going to order 25 MPH speed limit signs on our account for Vanderbilt Boro. They will pay us back and will come pick them up. Chairman Miner said that we are selling a Rubber Tire Roller to Saltlick Township for \$1,000.00. They will be picking this up. Motion by Supervisor Carson to sell the Rubber Tire Roller to Saltlick Township for \$1,000.00. Second by Vice Chairman Hann. All in favor. Motion carried. Lindsay will be sending an e-mail to Cypher and Cypher to obtain an update on the status of the 2016 and 2017 audits that have not yet been finished.
