Reorganization Meeting Minutes

January 6, 2020 * 7:00 PM

Call To order by Presiding Chairman

Pledge of Allegiance

Roll Call – Present were Donald Hann, Todd Miner, Robert Carson, Secretary Darla Hann

A motion made by Chairman Miner, seconded by Vice Chairman Hann to appoint Robert Carson as temporary Chairman and Darla Hann as temporary Secretary. Motion carried.

A motion was made by Robert Carson, seconded by Donald Hann to appoint Todd Miner as Chairman of the Board for 2019. Motion carried.

A motion was made by Robert Carson, seconded by Chairman Miner to appoint Donald Hann as Vice -Chairman of the Board for 2020. Motion carried.

A motion was made by Vice Chairman Hann, seconded by Supervisor Carson, to appoint Darla Hann as Township Secretary for 2020 at a rate of \$16.25 per hour/40 hrs. per week. With office hours being held at 166 McCoy Hollow Road and open to the public for business from 9:00 am to 4:00 pm. The Secretary will be bonded for \$150,000.00. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann to appoint Lindsay Boors as Township Treasurer for 2020 at a rate of \$16.00 per hour. The Treasurer will be bonded for \$150,000.00. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann to appoint Singer Accounting to do the Township Municipal Audit and quarterly checks. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann to appoint Jack Purcell as Solicitor for the Township at a retainer fee of \$2,000.00 per year and an hourly fee of \$95.00 per hour. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann to appoint Widmer Engineering as the Township Engineer. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann to appoint K2 Engineering and McMillen Engineering as the Sewage Enforcement Officers for the Township. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann to appoint Diane Mickey as Vacancy Board Chairman. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to appoint Fayette EMS as the Ambulance Service Provider for the Township. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to appoint Josh Nypaver as the code enforcement officer(s), at a rate of \$11.00/hr., as needed. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to authorize the Board of Supervisors (up to 3) and the Township Secretary to attend the 2020 PSATS' Annual Education Conference May 2-6, 2020 State Convention; authorizing the reimbursement of expenses in accordance with Section 1401 of the Second-Class Township Code of those officials attending the State Convention. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to appoint Todd Miner as the Voting Delegate to the 2020 PSATS' Annual Education Conference May 2-6, 2020 State Convention and a motion made by Chairman Miner, seconded by Vice Chairman Hann appointing Supervisor Carson as the alternate voting delegate to said convention. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to authorize the Board of Supervisors (up to 3) and Township Secretary to attend the 2020 County Convention; authorizing the reimbursement of expenses of those officials attending the County Convention. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to appoint SWRTB as the Township Earned Income, LSA, and Delinquent Per Capita Tax Collector. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to appoint Todd Miner as the Township Voting Delegate to the Fayette County Tax Collection Committee and a motion by Supervisor Carson, seconded by Chairman Miner to appoint Vice Chairman Hann and Secretary Darla Hann as the alternate Voting Delegates for said committee. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, setting the monthly meeting dates as the 2nd Thursday of each month at the Connellsville Township Municipal Office located at 166 McCoy Hollow Road at 7 P.M. The dates are as follows: 1/6/20, 2/13/20, 3/12/20, 4/9/20, 5/14/20, 6/11/20, 7/9/20, 8/13/20, 9/10/20, 10/8/20, 11/12/20, 12/10/20. The budget meetings will be held September 17th and October 1st 2020 and to advertise said meetings.

A motion was made by Chairman Miner, seconded by Supervisor Carson, to set the mileage allowance for employees (non-uniform and Union) using own vehicles as \$.57.5 cents per mile as set by the IRS for 2020. Motion carried.

A motion was made by Supervisor Carson, seconded by Vice Chairman Hann, to appoint Smith Towing Company to use on behalf of Connellsville Township for Code Violations. Motion carried.
