#### APPROVAL OF MINUTES

**Motion** made by Vice Chairman Upton to accept the regular meeting minutes from October 19, 2022. Second by Supervisor Hann. All in favor, motion carried.

### PUBLIC PARTICIPATION -

\* Lt. Shaffer from the Uniontown Police Barracks introduced himself. YTD calls for this year are 536, compared to last year, 542 calls. Criminal offenses are down from last year.

# SECRETARY'S REPORT (Treasurer Lindsay Zur reported)

- \* Monthly tax reports for October from Jim Stephens were submitted.
- \* The recycling grant was submitted on October 28th.
- \* The grant through the DA's office for Code Enforcement was approved and I have started ordering the items listed on the grant.
- \* Met with a representative from PennDOT to go over the Liquid Fuels roads in the Township.
- \* Several residents have called about the feral cat program and several cats have already been taken to the vet to be spayed or neutered.
- \* Jane Sandusky and Karen Mahokey have each called the Township to thank the road crew for picking up leaves and saying they always do a great job.
- \* We received new electric bill rates, the lowest from 14 companies, and they have increased, almost double. Chairman Miner suggested that we call West Penn Power to get their rate before deciding.

178 \* Our Armstrong contract for phone and internet is up for renewal. We currently have their lowest tier of internet service. To increase the internet speed we have now will be an additional \$40.00/month, making our internet cost \$109.95 Motion by Vice Chairman Upton to move to the next level of internet service, keeping our phones the same, 2<sup>nd</sup> by Supervisor Hann. #### Code Enforcement Officer -

\* Joe Adams reported that in the last 2 weeks he has sent out 3 certified letters, cited for an illegal burn. He noted Mr. Reilley has 60 days to clean up his property. He recommends that we remind people that according to our ordinance garbage needs to be in garbage cans. He also inquired whether all businesses are required to have dumpsters. There is a daycare in the Township that seems to have a lot of garbage and it is just sitting out in bags.

\* Report for the month was read by Jon Gilpin and is on file in the office. He stated that next week will be the last week for loose leaf pick up. The Township will continue to pick up bagged leaves as needed. He also thanked the city, South Connellsville Borough and Bullskin Township for their help on Casparis Road.
