ORDINANCE NO. 2019-4

AN ORDINANCE OF THE TOWNSHIP OF CONNELLSVILLE, FAYETTE COUNTY,
PENNSYLVANIA, REPEALING AND REPLACING SECTION 9 (FINES and PENALTIES) OF
ORDINANCE NO. 2018-5, ALSO KNOWN AS THE SWEEP ORDINANCE

IT IS HEREBY ordained and enacted by the Board of Supervisors of Connellsville Township,
Fayette County, as follows:

SECTION I. REPEALER

This Ordinance hereby repeals Section 9, Fines and Penalties, of Ordinance No. 2018-5, also
known as the SWEEP Ordinance.

SECTION II. WILL READ AS FOLLOWS:

- A. Any person who violates this Ordinance shall pay a fine as set forth herein for each
offense, plus all direct and indirect costs incurred by the Township for the cleanup and
abatement of the violation.

- B. Failure of the person to make payment within fourteen (14) days of the date of a violation ticket shall result in the filing of a citation, for failure to pay, with the Magisterial District Judge.
- C. If violations are continuous or egregious, Code Officials have the right to issue citations without first issuing tickets, provided notice has been given.

This Ordinance shall take effect and be in force from and after its approval as required by law. ORDAINED AND ENACTED by the Board of Commissioners of the Township of Connellsville at a duly assembled public meeting held the 11th day of April, 2019.
